

Luxury Pool Table Warranty

Home Leisure Direct Ltd. hereby warrants that its luxury pool tables will be free from defects in materials and workmanship for 5 years. This applies to all brands and models sold by Home Leisure Direct Ltd. priced over £1997 inc VAT.

Unless expressly stated otherwise herein, this Warranty Agreement ("Warranty") is made to the original Buyer only and is not transferable. Home Leisure Direct Ltd. guarantees its luxury pool tables against defects in material or workmanship, excluding normal wear and tear. At its sole discretion, Home Leisure Direct Ltd. will elect to either repair or replace any parts that are deemed to be defective. Any products sold for commercial purposes are excluded and are covered a 90 day parts warranty only with no cover for cloth or accessories.

This warranty is valid from the initial date of purchase and is subject to the restrictions set forth below:

Home Leisure Direct Ltd. warrants that the cloth will be free from defects in materials and workmanship for one (1) year from the date of installation. Friction marks and scuffs on the cloth occur naturally over time with regular play and are therefore not covered by the terms of this Warranty. Home Leisure Direct Ltd. agrees to (at its discretion) repair, replace, or refund the cost of any and all parts determined by Home Leisure Direct Ltd. to be defective, either in material or workmanship, with no charge to the Owner. Home Leisure Direct Ltd. is not required to and will not replace the entire table, piece of furniture or product. To request warranty service under the terms of this Warranty, the Owner must contact Home Leisure Direct Ltd. This Warranty is subject to the conditions and limitations set forth below. In no case shall Home Leisure Direct Ltd. be liable for any special, incidental or consequential damages for breach of the Warranty or any implied Warranty.

This warranty does not apply to: (a) normal wear and tear; (b) yellowing of billiard balls; (c) defects or damage due to accident, alteration, abuse, misuse, dropping, natural disaster, neglect, or failure to provide reasonable and necessary maintenance; (d) demonstration tables, furniture or product, floor samples (unless proven structurally defective, the definition of which does not include nicks, dents, scratches, gouges and flaws resulting from daily wear and tear due to being a floor sample or resulting from disassembly and reassembly of the floor sample), pre-owned products (other than as expressly set forth herein) and non-commercial tables used in an institutional or commercial setting; (e) bed cloth, pockets, and cushion rubber (unless proven defective, in which case Home Leisure Direct Ltd. shall provide a replacement to Owner, the installation of which shall be the responsibility of Owner); (f) tables, furniture, product, and/or components that have been installed or repaired by parties other than Home Leisure Direct Ltd.; and (g) damages exceeding the cost of the table, furniture, or product. Home Leisure Direct Ltd. makes no warranty, express or implied (including any implied warranty of merchantability or fitness for a particular purpose) other than those expressly set out in this Warranty. No action arising out of any claimed breach of warranty may be brought more than one (1) year after the cause of action has accrued.
